TERMS & CONDITIONS

1. Membership

- A. Membership includes the use of the facilities and amenities as described on your membership application.
- B. All members to produce their current membership card every 1st of the month and to register at the activity center every visit.
- C. No person under the age of 15 years will be allowed to become a member of the fitness center. No persons under the age of 15 years will be allowed to enter the fitness center area.
- D. Time-stops are available with a minimum of 2 weeks and a maximum of 2 months (depending on your membership term). Time-stop will not be given after the event & all time-stops are at management's discretion. This is available only for 6 and 12 months memberships.
- E. Management reserves the right to change timetable (opening hours).
- F. Management reserves the right to refuse patrons entry to the gym.
- G. Membership fees are payable in advance between the 1st and the 5th of the month and is not transferable or refundable.
- H. Activities undertaken at BWC are done so at your own risk.
- I. 15-minute time limit on cardio equipment at peak time.
- J. For new memberships or renewal of membership please contact The Fitness Center Manager. Rules and Regulations are subject to change without notice.
- k. All members are requested to park vehicles outside the resort at the old Sunset parking lot.

2. Dress Code and Hygiene

- A. All members are requested to bring a sweat towel to wipe down Gymnasium equipment after use.
- B. Gymnasium-appropriate attire (athletic/sports clothing, sports and athletic footwear) must be worn in the gymnasium. Members with incorrect attire and footwear / worn out aerobic shoes will be asked to leave the gymnasium for reasons of safety. As a matter of custom and etiquette, removal of t-shirt/upper is not permitted in the gym.
- C. All members are requested to enter the gym with non beach shoes, free of sand/mud.

3. Etiquette and Behavior

- A. The gym is a non-smoking area.
- B. Food and beverage items are not allowed in gym.
- C. Pets are not permitted in the gym.
- E. Members are requested to respect the rights of other users and refrain from shouting, foul Language, boisterous behavior and using electronic loud equipment.
- F. Changing of clothes only allowed in the locker/changing rooms.

4. Liability

BWC and The Hotel will not be liable for any loss or damage to property what-so-ever or any bodily injury (ies), death or illness of any member and/or guest, how-so-ever caused sustained or incurred or incurred arising out of or in any way connected with the use, whether proper or otherwise, of any of the equipment and/or facilities, whether defective or not of the gym.

5. Temporary Regulations

BWC reserves the right to alter the operational times of opening and closing of the gym facilities at its discretion. It further reserves the right to close all or any facilities for any reasonable period for reasons of re-building, re-organizing or repair, for which no compensation/ refund should be asked for or any dispute raised.
